#### **RENT IN ADVANCE**

The tenant shall pay upfront an amount of four (4) weeks rent in advance, this will be a total of \$800. This payment will be held by the landlord and applied to the tenants rent account to keep the rent payments in an 'advance' status.

#### **UTILITIES**

Utilities and other bills required for the maintenance and operation of the premises shall be paid by the Tenant.

#### **ALTERATIONS**

No alterations or modifications can be made by the Tenant without the proper and written consent of the Landlord. Any changes or modification made by the Tenant upon expiration of the lease shall be retuned by the Tenant at his own expense.

#### **RETURN OF DEPOSIT**

Upon termination of the rental contract, the Landlord shall return the remaining security deposit to the Tenant within but not more than 14 days of vacating the premises or otherwise stipulated in agreement of the tenant and landlord.

#### **MAINTENANCE AND REPAIRS**

Ordinary maintenance and repairs during the tenancy agreement shall be borne by the Tenant.

Extraordinary repairs however which by circumstances caused by fortuitous events shall be borne by the Landowner.

#### **MODIFICATION AND ALTERATION**

No modification shall be considered as having been made in this agreement unless otherwise set forth in writing by the contracting party hereto.
